For attention of Commissioner Coster, Deputy Commissioner Kura, Superintendent Hassan, Inspector Srhoj, Inspector Ruth, Inspector Fergus, Inspector Laurenson

Hello everyone

I hope this email finds you all in good health.

I ask that you will all give what I discuss your full consideration.

As you are all aware, I have been raising my concerns around the legitimacy and safety of the COVID response, and gene therapy vaccination for COVID since 5th of March 2021 when at the time I was employed by NZ Police.

I sent a code of Conduct report to Commissioner Coster and from then had numerous interactions over this, masking orders in the Police, and the mandating of Police staff to accept the gene therapy treatment being touted as a vaccine.

Prior to my departure from NZ Police I tried more than once to raise the alarm about fraudulent activity around the COVID testing, and mis representation to the public about what it was they were to be injected with and the potential harms facing those that took the gene therapy product.

Inspector Srhoj, I remember you telling me at Wellsford Police Station when you visited me there that Police do not investigate Government and that if afterwards wrong doing was found to have been done then those responsible would be held to account.

Commissioner Coster and Deputy Commissioner Kura, you both breached my Health and Safety in the workplace by failing to answer relevant health and safety questions I directed to you both prior to the attempted termination of my employment for not complying with the gene therapy treatment mandate. Commissioner Coster you were still advocating for the gene therapy treatment (jab) during the zoom call you had with all mandated Police after we successfully appealed the mandate, when reintroducing us back to the workforce. In this call I asked you about the NZDSOS letter you received warning of dangerous contaminants in the gene therapy treatment and you did not answer.

You also continued on with your directive to all staff to obey your mask rules with no tolerance for exemptions despite the legislation allowing for it. Im not sure whose authority you were acting under on that.

Inspector Ruth, you dismissed my complaint file number 220221/3183. I obtained the communications had between yourself and Detective Senior Sergeant John Clayton under an Official Information Act request. It was very disappointing to see the level of bias displayed in these communications and the use of language to portray an emotional anti vaxer in your correspondence. Detective Senior Sergeant Clayton even admitted he did not look at the supporting evidence provided as there was too much (evidence??). This was also attempted to be justified by saying the information provided had been taken from the internet and chosen to suit my anti vax position, yet a lot of the information was from University of Otago, WHO, Vigi Access a vaccine injury reporting site of the WHO, Pfizer, The Lancet medical journal, and other peer reviewed scientific studies from varied sources.

At least you thanked me for my professionalism in the letter you sent saying you weren't investigating any further.

Superintendent Hassan, during one of our meetings you asked what Police could do for me and I asked for a taskforce to be set up using mandated at the time staff so as not to disrupt staffing any further, to investigate elements of fraud and harms caused by the NZ Govt and Health officials COVID response. You declined and expressed full confidence in the NZ Govt and Commissioner Coster.

You further went on to say that if you weren't so high ranking in the Police then you would have stood beside us to oppose the mandates.

One of you said that you had an adverse reaction to the jab and dismissed it saying you were told to expect a possible adverse reaction.

Another of you said that you had suffered an adverse reaction affecting your heart and this had left you concerned about your health, and you thanked myself and others for standing up against the mandates as you didn't know what you would have done if you had been required to have boosters. You also said that if ever challenged on these comments you would deny having made them.

A few of you also said that I may well be right in some of my concerns and Superintendent Hassan, one of the last things you said to me was that if I was right then in a couple of years time I would be able to say I told you so.

Well it truly gives me no joy at all to say I told you so, but here we are.

As uncomfortable as it may have made you feel reading the above, its no where near as uncomfortable as its been for the many thousands of New Zealanders now harmed or dead due to the gene therapy treatment they have been exposed to.

As leaders in the NZ Police and having previously been provided with information of significant concern to the safety and well being of the people of New Zealand you have all contributed towards the harms by way of failure to adequately investigate or speak up.

I would like to draw your attention to a case currently in the Australian Federal Courts relating to Pfizer and Moderna jab products being GMO's and having very high levels of dangerous DNA contamination brought about by the mass production manufacturing processes used by Pfizer and Moderna.

The result of these manufacturing processes for mass production has been a contaminated product that contains extra sequences that have disabled cancer protecting parts of the immune system allowing cancers to grow in an accelerated manner in people which has brought on the term turbo cancers which are now being experienced. This is along with a host of auto immune diseases appearing in otherwise healthy people.

The Pfizer product approved for Emergency Use Authorisation is a different product than the one supplied to the World including New Zealand. Pfizer gained no approval for the different product supplied. As a result tremendous harms have occurred.

Commissioner Coster, NZDSOS, New Zealand Doctors Speaking Out With Science have put an open letter out that is addressed to you and other leaders and protectors of New Zealand. Although you chose not to act on their previous concerns and warnings, it is in your best interest and that of New Zealand for you to read this very well constructed summary with supporting evidential documents explaining the disastrous issues identified with the Pfizer product and the consequences.

To support these concerns it should be acknowledged that over 60,000 New Zealanders reported vaccine injuries to CARM with 250,000 symptoms of harm. Undoubtedly this will be the tip of the iceberg with many likely to develop rapid cancers, auto immune diseases, heart damage and more. With the majority of NZ jabbed with this contaminated Gene therapy treatment, we are in for more harm as the long term consequences are still unknown. It also appears that the damage is often irreversible as the subjects DNA is permanently altered.

Further I have just received the results of an OIA to Police which includes the number of sick leave hours consumed by staff yearly from 2015 to current. As you can see there is a massive jump up in 2022. Police try explain this as the affects of an ageing Police, and COVID-19. I don't accept these as valid reasons for a sudden one year spike.

I understand that anyone sick was told to stay home. However in 2022 almost all Police staff were jabbed with the COVID gene therapy treatment. In theory they were all protected with this safe and effective product so should not have been experiencing much sickness at all that could be attributed to COVID in 2022.

Similar experience can be seen by examining the reinfection rates for COVID in vaccinated vs unvaccinated. The vaxed are through the roof for re infection while the unvaxed are not. This data is held by our Ministry of Health and is accessible.

Feel free to look at attached OIA response from Police on Sick leave.

All of you have also jeopardised the well being of Police staff as well as the public by your lack of performance in executing your duties in an unbiased and honourable way. If you had performed your duties more responsibly, many lives could have been saved and much pain and suffering avoided.

The new information provided on contamination of the Pfizer product and their switching of manufacturing process after EUA approval without notification to regulators, by a company (Pfizer) with an extensive criminal history for Fraudulent mis representation of medicines, has provided you all with a unique and possible last opportunity at redemption if you choose to do the right thing and launch a criminal investigation into this whole sorry mess. The change of Government may also provide the breathing space required to follow through before they push on with the jabs just as much if not more than the last Government

Bear in mind that you all were warned numerous times as was our Government and Health authorities that chose to continue while they knew harms were occurring, evidenced by their own recording of injury and death.

Even if any of you exit the Police, you will be accountable for what you did or didn't do during this crisis.

There are many in New Zealand that could and would assist a Police enquiry run with professionalism and integrity without any Political interference.

The wrong doing has been done and now its time to hold those responsible to account. Time to stand behind those comments.

I was never a conspiracy theorist or an anti-vaxxer as you have suggested in correspondence between yourselves. I just saw something wasn't right, investigated and followed the evidence that led me to the conclusions I came to. Sadly most Police were so afraid of COVID they lost their ability to think clearly.

Its time for you to catch up.

You must realise that there is no legal justification to continue to vaccinate into the population with the knowledge that some will be injured and some killed as a result of. You must realise that the very basis of our legal system is founded in the the Rule of Law - which principles include the right to life, and the right be free of medical experimentation and that we are all equal and accountable under the law.

This is an appalling situation and the Police must act in accordance with the law. I refer you to the Police Act s8(a)(d)(e)(f) and s9(c)(d)(e)(f)(h) which sets out your legal responsibility.

Please act in accordance with the law.

Please respond to me at your earliest convenience with a decision on whether you choose to act or not.
